

#### **US Department of Transportation**

Last week the Department of Transportation announced that \$2.9 billion is now available for major projects—including those related to rail—through a new funding opportunity that combines three different transportation grant programs. By combining the **INFRA**, **Mega** and **Rural** grant programs under a single Notice of Funding Opportunity (NOFO), the new **Multimodal Projects Discretionary Grant** (MPDG) seeks to reduce the burden on state and local applicants, making is possible for communities to apply to one, two, or three major programs using a single application and common set of criteria.

Applications for MPDG are due May 23. Additionally, applications for the **RAISE program** are due April 14.
