JUSTICE KETANJI BROWN JACKSON

This week, Judge Ketanji Brown Jackson was sworn in as Supreme Court justice, replacing Justice Stephen Breyer.

Justice Brown Jackson made history as the first Black woman to serve on the nation's highest court.

As I pen this message, I am filled with pride and joy as Judge Ketanji Brown Jackson was sworn in as the 116th Justice of the Supreme Court. She makes history as the first Black woman to serve on the highest court. Moreover, Justice Jackson joining the court will also make the first time in our history that four women will sit on the high court bench simultaneously.

Justice Jackson said in a statement: "With a full heart, I accept the solemn responsibility of supporting and

defending the Constitution of the United States and administering justice without fear or favor, so help me God. I am truly grateful to be part of the promise of our great Nation.”

Congratulations, Supreme Court Justice Ketanji Brown Jackson! We are very proud as you take your place on the highest court in our country.

Reflecting on Justice Jackson’s powerful words, I can relate to her sense of duty. Her statement reminds me of the great responsibility we, too, have as municipal elected officials. Every day we work to make a positive difference in our respective cities. And as members of FBC-LEO, we have collectively strived to overcome challenges, generate new opportunities and utilize the united efforts of this great organization to support our municipal work. Alachua Hits Milestone in Protecting Drinking Water, Celebrates Natural Stormwater Management System

The City of Alachua is celebrating the completion of a long-awaited project to protect the Mill Creek Sink system. The Mill Creek Sink Water Quality Improvement Project began several years ago, and the finished natural stormwater management system includes a filtration system that collects and treats runoff from the nearby interstate and existing commercial business drainage structures. On May 31, City of Alachua commissioners and staff along with representatives from SRWMD, gathered with the public to celebrate the completion of the project with a ribbon-cutting ceremony and tours of the completed wetlands project. Offering comments were Alachua Mayor Gib Coerper, Interim City Manager Mike DaRoza and Alachua Public Services Director Rodolfo Valladares. They were joined by Alachua City Commissioners Ed Potts, Dana Miller, Shirley Green Brown and SRWMD Governing Board Chair Virginia Johns to cut the ribbon and officially open the natural wetlands collection barrier system.

The Florida Housing Finance Corporation launched the Hometown Heroes Housing Program this month.

The Florida Hometown Heroes Housing Program makes homeownership affordable for eligible frontline community workers such as law enforcement officers, firefighters, educators, healthcare professionals, childcare employees, and active military or veterans.

This program provides down payment and closing cost assistance to first-time, income-qualified homebuyers so they can purchase a primary residence in the community where they work and serve. The Florida Hometown Heroes Loan Program also offers a lower first mortgage rate and additional special benefits to those who have served and continue to serve their country.
